Message from the Chair Regarding Changes to By-Laws

As many of you may know from your affiliation and participation with other groups within the CSCA, David McMahan, CSCA Second Vice President has been coordinating efforts to bring the By-Laws of the individual interest groups inline with the By-Laws of the overall CSCA. Apparanetly, many groups didn't even have By-Laws or they were radically different from those of the overall organization. Thus, the call went out a few weeks ago to correct the discrepancies.

I'm pleased to say that our By-Laws were in great shape overall! However, we did have a couple of things that required fixing, and contained within this newsletter is an amended version of our By-Laws that we will be voting on at our April meeting.

The key issue that had to be addressed was the fact that our Chair needs to also be the program planner for our group in future years (a service currently done by our Vice-Chair). When correcting this issue, the Executive Committee thought it prudent to also revise the structure of our group to be more in-line with other interest groups within CSCA, and thus, the proposal also eliminates the Vice Chair-Elect and the Secretary-Elect positions and places the 3 remaining officer positions into a 3-year cycle wherein Secretary will serve for a year and become the Vice-Chair who will serve for a year and become Chair.

Also added is an Article listing formally the two awards recognized by our group each year for Top Paper and Top Student Paper.

Please look these changes over and come to the business meeting in April ready to ask questions, make/suggest changes, and vote on the amendments to our By-Laws. Please note, though, that the change regarding the program planning duties of the Chair is, from what David has said, a non-negotiable aspect of the changes. To not make this change would mean we would be in violation of the organization rules and our program spots as a group would literally be taken away, so hope you like this change because, in short, it needs to happen.

Proposed Amendments to By-Laws

CENTRAL STATES COMMUNICATION ASSOCIATION Political Communication Interest Group

BY-LAWS

ARTICLE I: NAME

The name of this organization shall be the Political Communication Interest Group of the Central States Communication Association.

ARTICLE II: PURPOSE

The purpose of the Political Communication Interest Group is to support the teaching and research of political communication. The scope of this Interest Group is broad, as the study of politics and communication may encompass the communicative activity of citizens, individual political figures, governmental institutions, the media, political campaigns, advocacy groups and social movements. This Interest Group recognizes and encourages research that addresses political communication topics in all contexts and levels of analysis, employing a variety of methodologies.

ARTICLE III: MEMBERS

Membership in the Political Communication Interest Group shall be open to all those who are members in good standing in the Central Sates Communication Association and who are interested in advancing the purpose of the Interest Group.

ARTICLE IV: OFFICERS

Section 1. The officers of the Political Communication Interest Group shall be: Chair, Vice-Chair, and Secretary,

Section 2. The Chair, Vice-Chair, and Secretary serve for a staggered three-year term. The Secretary will serve for one year, then succeed to the office of Vice-Chair for one year, and then succeed to the office of Chair for one year,

Section 3. The Chair shall serve as the presiding officer of all Interest Group business meetings and at all Executive Committee meetings. This officer shall discharge the usual responsibilities adhering to such an office, shall serve as a representative of the Interest Group, and shall be responsible for seeing that the provisions of the By-Laws of the Interest Group are enforced. <u>The Chair shall serve as the Interest Group's primary program planner for the annual meeting of the Association</u>.

Section 4. The Vice-Chair shall assist the Chair in planning the Interest Group's program offerings for the annual convention, and shall perform the duties of the Chair in the event of that officer's absence or incapacity.

Section 1. Standing or special committees shall be appointed by the Chair as the Interest Group or the Executive Committee shall from time to time deem committees necessary to carry on the work of the Interest Group.

Section 2. The Chair shall be ex officio a member of all Interest Group committees.

ARTICLE IX: PARLIAMENTARY AUTHROITY

The rules contained in the current edition of Robert's Rules of Order, Newly Revised shall govern the Interest Group in all cases to which they are applicable and in which they are not inconsistent with the By-Laws and any special rules of order the Interest Group may adopt.

ARTICLE X: AMENDMENT OF BY-LAWS

These By-Laws may be amended at any regular meeting of the Interest Group by a majority vote of those individuals present and voting, provided that the amendment has been included in the Interest Group's most recent newsletter. If a proposed amendment to the By-Laws has not been included in the newsletter, it may be considered at an annual meeting, but the amendment requires a majority vote of the Interest Group's entire membership to pass.

PROPOSED AMENDMENT:

Article XI: AWARDS

Each year at the annual conference, the interest group will present two awards: The Top Paper Award for the member of the interest group who submits the most impressive competitive paper of the convention, and the J.
