Message from Mitchell McKinney, cont.

First, we wanted to increase the presence of political communication scholarship at our annual meeting; second, we wanted a professional service venue that would facilitate the development of junior scholars; and, finally, we wanted to promote our future political communication scholars and teachers by encouraging and recognizing political communication research among graduate students. On all three fronts, I'm happy to report, we've been quite successful.

When I review the list of Interest Group officers for the past decade, I note names of colleagues who have successfully transitioned from graduate students to Assistant and now Associate Professors; and several of our past CSCA Political Communication Interest Group officers have gone on to serve as officers of NCA's Political Communication Division. In terms of developing our future political communication scholars, each year since 2003 we have

awarded the J. Jeffery Auer Award to the top graduate student paper. Among this group of recipients, many have already assumed faculty positions and are now mentoring our next generation of political communication scholars. And, of course, each year at our annual meeting some of the highest attended and most interesting panels are sponsored by our Interest Group (even if I am a bit biased in making this assessment).

Perhaps the most gratifying part of the past ten years has been the many friendships and collaborations that have developed. I feel fortunate to have been part of this wonderful group and look forward to many more years of fun!
