Plan 2021-2022 Submissions:

1. General GIFT suggestions: Great place for graduate students to submit. Possibly in 2022 for GIFT to present all ideas. Will send a poll to GIFT members to receive feedback on if roundtable approach should change. Another suggestion made to create a list of especially challenging topics to each to encourage some focused Great Ideas For Teaching.

Proposed Changes to GIFT Bylaws:

- 1. Article IV Section 2 Current Language:
 - "Only those who are both members of the Central States Communication Association and the Interest Group (as designated at the time of convention registration and membership renewal) and are not graduate students are eligible for office."
- 2. Proposed Changes to Article IV Section 2:
 - "Only those who are both members of the Central States Communication Association and the Interest Group prior to elections are eligible for office."
 - a. Justification: Current chair is a graduate student and has been since being elected as Secretary.
 - i. Eliminating this stipulation is more reflective of the standards of the other CSCA Interest Groups.
 - b. Memberships can be added and changed *after* registration and membership renewal.
 - i. New language of "prior to elections" keeps it such that for an individual to be elected to office, they need to be members of both CSCA and GIFT.
- 3. Discussion: Other regional conferences do not have GIFT Interest Groups. GIFT is a good place for graduate students to get involved for those starting careers in higher education.
